The Challenge

Prior to implementing VisibleThread, Parker Hannifin's contract review process was:

- **Time-consuming and manual** Contract administrators spent excessive time on document preparation before even starting on contract review.
- **Prone to error** The tedious nature of manual contract review led to user fatigue and increased the potential of errors.
- **Inefficient** The contract review process was manual and involved constantily scrolling through differently templated documents was a time-consuming process.

The NDA review process was particularly cumbersome, with each agreement requiring individual assessment against company policies and legal guidance. Contract specialists needed to manually compare terms across documents while cross-referencing with legal guidelines. For document comparisons, reviewers needed to work across multiple screens, manually scroll through each document, laboriously identify differences between versions and coordinate feedback across multiple divisions during group-level reviews.

NDA Dictionary

The team has created a comprehensive collection of search terms with corresponding legal guidance to streamline the NDA review process

VisibleThread automatically flags critical terms (such as "Intellectual Property") and provides Parker's contextual legal guidance, making reviews more efficient and thorough

The platform generates fully annotated documents with clear, actionable comments that simplify the redlining process for reviewers

Document Comparison

VisibleThread quickly identifies and highlights differences between multiple document versions without the tedious manual effort previously required

This facilitates collaborative group-level reviews by enabling each division to populate and maintain their own dedicated column of feedback – making meetings more efficient

It enables intuitive side-by-side comparison of various document types with endless use cases - from technical specifications to detailed job descriptions

Produces easy-to-navigate color-coded Excel outputs that can be easily filtered



FAR/DFARS review

Using VisibleThread, Jen and the team can automatically reviews contracts against FAR/DFAR regulations and established company policies

In addition to understanding Parker Hannifin's stance on the clauses, VisibleThread automatically identifies the clauses that need to flow down to sub-contractors ensuring compliance

The dictionaries provides clear positions on each clause (acceptance, conditional acceptance, or decline) with supporting rationale and are fully customizable

- Simplifying complex tasks: The document comparison functionality has simplified complex review tasks: "This is so much easier—with this format, you can quickly understand the main differences instead of having to read through manually. It's nice because VisibleThread lines things up in an intelligent way that works just like your eyes would"
- Streamlined redlining process: "As you're going through, you can redline right then and there, close out the VT comment, and complete the redline—making sure you don't miss any of the relevant terms. And just like that, you have the redlined draft ready to submit to the customer."




Conclusion
